### **Project Background**

Vermont River Conservancy protects and restores rivers for people and wildlife. We conserve land along rivers throughout the state through river corridor easements and other easement types. In addition to private river corridor easements designed to improve flood resilience, water quality, and wildlife habitat, we manage several swimming holes, paddling launches, campsites, and fishing holes that are open to the public.

We are engaged in coordinating a state-wide collaborative effort to highlight the recreational value of our rivers while encouraging folks to recreate safely and with care for the ecological characteristics of our conserved lands. As part of this campaign, Vermont River Conservancy is seeking proposals from local photographers who can provide beautiful photos that reflect the beauty of Vermont's rivers and promote safe river recreation.

# Scope of Work

We seek a photographer to capture the following:

- Safety-related images of individuals demonstrating the safe and unsafe use of rivers for recreation.
- Images that illustrate and encourage low-impact engagement with our rivers.
- Stewardship activities and other on-the-ground work, documented during volunteer workdays or site visits with our stewardship team.
- Images of sites offering public access to rivers.
- Close-up shots of wildlife, plants, and stream features.
- Imagery depicting natural river patterns and fluvial processes. Drone photography is highly desirable.

Given this project's scope, photographers should be prepared to cover multiple sites across north-central Vermont, including travel between locations and coordinating multiple days of shooting.

  - What's your connection to rivers, and why are you excited to work with Vermont River Conservancy?
  - A description of how you plan to execute the Scope of Work and adhere to the project timeline.
  - As part of this project, you will provide deliverables that address Vermont River Conservancy's Scope of Work and organizational needs.
  - What is your proposed budget for completing this project?
